Goals: to coordinate the activities of the members of Federation, to represent the interests of Federation and to protect thereof, to answer other public interests, to execute the goals indicated in the Articles of Association, related to the activities and needs of the members of Federation, including: to seek the development of winter unifight in all countries over the world; to maintain the intercourses with official organisations and individuals, providing technical, administrative, financial support for the development of winter unifight; to contribute actively to the cultivation of mutual understanding, friendship and peace of nations of the world, to create favourable conditions for the good relationships between the states for the support of the members of Federation, to respect the interest of the each of them; to propagate the program of winter unifight approved by the Federation, to organise the international competitions of the winter unifight; to execute the control of development of the winter unifight and to ensure that all sport organisations, which belong to Federation, shall observe the rules established, also during the international competitions which are under the control of organisations affiliated to Federation; to improve qualification of international referees, coaches, sportsmen, to licence and to control the activities of their technical and administrative personnel; to organise the international tournaments, the cup sport competitions of Europe, Asia, America, Australia continents, to participate in European and world championships, to organise the conferences, symposiums, sport seminars, qualification improvement courses; to support and promote the cooperation of the sportsmen and sport organisations with similar sport organisations of the Republic of Lithuania and other countries; to ensure the representation of the winter unifight sport organisations and federations at the National Olympic Committees and International Olympic Committee, other international sport organisations; to accept neutral decisions in case of controversial matters or disagreements which could rise between organisations affiliated to Federation.
